Through the Department of Children, Youth & Families (DCYF), you may be eligible for the Working Connections Child Care or Seasonal Child Care subsidies. The MSCC board of directors (BOD) requests that all families apply (dcyf.wa.gov) for the subsidy program in addition to tuition assistance.

MSCC Scholarships are need-based and available at the discretion of the BOD, who may choose to limit scholarships based on enrollment, licensed capacity, staffing, and community needs. The number of scholarships awarded may change at any time at the discretion of MSCC. MSCC does not guarantee the total amount requested will be awarded. A negative determination may not be appealed; however, a new application may be submitted anytime.

Type of scholarship	Monthly: job loss, illness, death, reduced income, etc... affect a family's ability to pay from time to time. Unforeseen circumstances should not prevent your child's continued enrollment at school.	Yearly: We prioritize a robust scholarship program to ensure that all families have access to enrollment at Mountain Sprouts.
Award Amount	Reduction for one month of tuition.	Reduction to annual tuition rate (applied to each month's invoice).
Availability	Families can be awarded up to 3 times per school year.	Can reapply every year.
Application Timeline:	MSCC BOD reviews applications during meetings on the third Thursday of the month. Scholarships approved at these meetings will be applied to the following month's tuition.	MSCC BOD reviews applications during their meetings on the third Thursday of the month. Submit your application for a yearly scholarship as soon as you are able for the desired school year. Scholarships are also granted mid-year for the remainder of the year determined by available funds.
